REQUIREMENTS:

- The Cobb NAACP Juneteenth Celebration Festival Committee must receive a completed application form and payment in full of all fees by June 10, 2010.
- Amusement and food vendors must submit certificate of insurance with completed application form.
- All vendors are required to submit two pictures of the items they plan to sell at the festival and one picture of the display itself.
- The Cobb NAACP Juneteenth Celebration Festival Committee reserves the right to make booth assignments and the right to reject any applications. All fees will be returned for rejected applications.

FEES:

- A non-refundable \$50.00 fee for each 10'x10' space must accompany all applications. If electricity is required, please include an additional \$5.00 with application. Water hookup is NOT available and electric hookup is limited. Food vendors, please take note. All spaces will be \$50.00, regardless of status.

PARKING:

- Once exhibits are unloaded, all vehicles must be moved to designated parking areas.

BOOTHS:

- Booth space measures approximately 10' x 10'. Multiple spaces are available.
- Spaces are numbered and marked on the sidewalk. Upon acceptance, you will be notified of your space number and/or location.
- Vendors MUST contain their display, work, and storage within the dimensions of their booth.

GENERAL RULES:

- All participants are expected to provide their own tables, chairs, canopies, extension cords, etc.
- Participants are required to stay open from 10:00 am until 7:00 pm.
